2. that my residence or domicile is in Tuscany / that my residence or domicile is in Italy but I have chosen to pursue my artistic activities in Tuscany (delete where not appropriate);
3. that I am not an employee, collaborator or consultant of Autolinee Toscane s.p.a., nor a temporary worker or an employee of a subcontractor of Autolinee Toscane s.p.a. or a supplier of goods and/or services to Autolinee Toscane s.p.a., nor a relative up to the fourth degree or relative by marriage up to the second degree of said parties;
4. that I am the sole author of the artwork submitted and the exclusive and legitimate owner of the copyright to my artwork, including the rights to its use and exploitation, also economic and in terms of its dissemination and publication, and therefore exempt the Promoter from any civil or criminal liability in this regard, including towards third parties, and hold the same Promoter harmless from any damage that may arise from the performance of promotional activities and other connected activities pertaining to the Event;
5. that I have acquired, where necessary, any waivers or rights from relevant entitled parties in relation to my artwork as per point 5 on copyright and the rights of use and exploitation, also economic and in terms of dissemination and publication;

6. that, where necessary, I have pre-emptively obtained from the relevant parties – also pursuant to and for the purposes of the provisions of EU Regulation 2016/679 (GDPR) and Italian Legislative Decree no. 196/2003 – all consents and waivers provided for by current regulations regarding the use and publication of the material submitted for participation in the Event and for the conferral / transfer to the Promoter of the rights indicated above.

By signing this document, I also declare that I consent to the request for confirmation of the facts, conditions and personal information declared herein, pursuant to art. 71 of Italian Presidential Decree no. 445/2000.
