Please note that this request is valid only if submitted together with a photocopy of the signatory's identification document, accompanied by the following declaration: "I, the undersigned (name and surname), born in (place of birth) on (date of birth), and residing at (residential address), hereby declare that the attached document is a true copy of the original in my possession.
